 - (i) The institution has acquired the land for setting up the teacher education institution.
 - The institution has constructed the building for conducting the course on (11) the above mention .: iand.
 - The institution has created an Endowment Fund of P.s. 5.00,000.00 (iii) (Rupees Five Lacs inly) and a Reserve Fund of Rs. 3.00.000.00 (Rupees Three Lacs Only .
 - The institution has ratiated the process for recruitment of Principal / Head (iv) of Department and ruchers for the said course.
- Now, therefore, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act. 1993, the Regional Committee hereby grants recognition to Institute of Teacher Education, Meerut - Delhi Road, Kadrahad, Modi Nagar, Ghaziahad, Uttar Pradesh - 201201 for an additional intake of 40 (Forty) seats in B.Ed. course of one year duration from the academic session 2002-2003 i.e. 60 (Sixty) to 100 (One Hundred) seats Subject to fulfillment of the following :-

- (a) That the institution will ensure that Principal / Head and at least Seven faculty members are in position for an intake of 100 (One Hundred) students before commencement of the course and a report of this effect, duly verified by the Registrar of the concerned University shall be sent to the Committee within one month of commencement of the course.
- (b) The institution shall within ONE MONTH of the receipt of recognition order, conved the Ensument Fund account into a joint account in the form of FDR for a period of not less than SIXTY MONTHS (Five years) in a Nationalized Bank only. (and not any other certificate) to be operated along with an official of the Regional Committee.
- (c) That the Reserve Fund for an amount equal to three months salary of the staff be maintained, if the form of FDR in favour of the management institution, for a period of not less than SIXTY MONTHS (Five years) in a Nationalized Bank

- (d) The institution shall comply with the various all other norms and standards as prescribed in the NCTE Regulations.
- 4. Recognition is subject to the condition that the affiliating university shall ensure that, among other things, the institution has appointed required number of faculty members (including Principal / Head of Department), as per the norms of the NCTE/UGC/Affiliating University.
- 5. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulator, rodies like UGC and State Government, etc.
- 6. The institution shall submit to the Regional Committee a <u>Self-Appraisal Report</u> at the end of each academic year a my with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts only audited by a Chartered Accountant.
- 7. If the institution contravenes any of the above conditions of any of the provisions of the NCTE Act. Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTF Act.
